

## Settlement Players AGM, 19<sup>th</sup> July 2023

### **(1.) Attendance:**

### **(2.) Minutes of 2022 AGM**

Stephen noted one amendment: current contract with Settlement is hire charge contract at £3000 in 2 instalments a year, plus 20% profit on shows. Payment will increase to £3300 in coming year (see item 5).

### **(3.) Chair's Report** – read by S. Charles, see Appendix 1

Additional comments:

- Centenary celebrations – aim is to have celebration in Jan 2024 (Christmas party with extras), an exhibition of Players' Memorabilia at the One Act evening in Sep 2023, possibility of getting some century merchandise.  
**ACTION: Committee to select someone to continue to investigate merchandise.**
- Matinee successful but is only possible when the dance academy does not need the space on Sat afternoon.

### **(4.) Treasurer's Report** – read by Alan Higbey, see Appendix 2

**ACTION: Alan to circulate accounts after they have been externally checked.**

Additional comments:

- Increase in payment to Settlement:
  - Upcoming £3300 charge covers all payments to Settlement.
  - Players made profit of £3600 in 2022-23, so we can comfortably absorb increase.
  - **VOTE: Approved 10% increase in payment to Settlement.**
- Currently 49 paying members of Settlement Players. **ACTION: Alan to send out email about renewal of membership & to new players to get membership.**
- Question about whether we should raise ticket price from £10 to be more in line with other local AD groups.
  - May limit ticket sales amongst some of our audience (especially younger audience).
  - Others felt there was not concern in limiting sales, but as we are currently making a profit there is no need to increase ticket prices at the moment (we can keep this for later if needed).
  - Suggestion that ticket price could increase to £10.50 or £11 but include programme, or that we could ask for donations for the programme (usually raises more than selling it).
  - Less well-known play did not sell as many tickets – we like having a balance of different plays but should share more about those that are not as well known.
- Noted that this year, more spending on play resulted in more profit (although slightly skewed by not having to pay licence fee for 'Earnest'). Suggested that a budget may be helpful for directors.

## (6.) AOB

- Massive thanks to all the backstage and technical crew who have done such fantastic work this year.
- Upcoming productions:
  - Sep underway (plays by Stuart & Claire) - £5 tickets, possibly cheaper drinks, smaller audience & online only booking.
  - Two ideas for Nov production (from Jenn/David) – committee simply needs to decide.
  - Nothing suggested yet for Mar/June 2024, although a possibility of David postponing his play until then (Jenn's is Christmas themed). Hamish suggested 'Dick Barton: special agent'.
  - **ACTION:** Stephen to send email to membership asking if anyone wants to direct.
- Frequency of committee meetings:
  - Aim to have more frequent committee meetings over the next year to hold people more accountable to their stated actions.
  - For this to be successful & useful, committee members need to come to the meetings with ideas & ready to volunteer.
  - We should also remember that it is possible to delegate certain tasks to other members not on the committee.
